**\*HK\$11,800 each or US\$1,500.- (covering incorporation and domiciliary services until renewal.)**

**P. S. Chinese names can be added and registered on the M&AAs of the newly incorporated companies at your request (Extra US\$180.-)**

The annual fee from 2<sup>nd</sup> calendar year will be at \*US\$800.- covering annual license and domiciliary services. One box file with full register contents, copies of M&As with 2 duly stamped by Registrar, Bearer or Registered Shares Certificates, Appointment of First directors, Subscriber and First directors' minutes, BVI Registered agent/office, Government license of first calendar year, Corporate seal and rubber stamp will be provided for each company.
